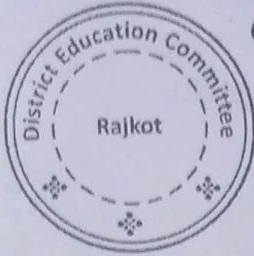

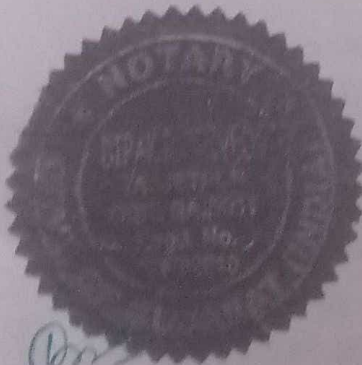

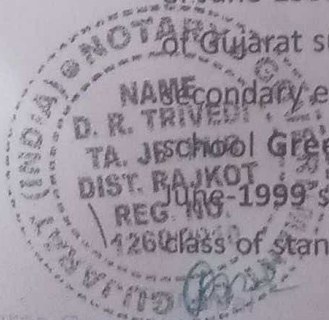

Sir,

As per the decision of the sanction of school board executive committee of June-1999, dated 27-07-'99 have to inform you that, talking into consideration of Gujarat sub-rule 1972 (Gujarat Sub-Rule Sr.No.18 of 1973) and rules taken for secondary education 1974 and decisions as per circulars of it; your above named school Green Farm High School, Kasturba Dham is registered to start from June-1999 subject to not to take grant forever. The school is granted to start a class of standard 8th and it's education medium shall be in English. You shall have






to abide to the following conditions. However, as and when it is found that if any of above conditions is not adhered then the board shall do necessary activity and shall cancel the consent of the school as per rules.

The Condition for Registration :

1. The board must be satisfied for the executors and trustable and it's administration is proper and the executors are financially sound.
2. The officers of the board or the person who is entrusted to visit the school should be allowed to inspect the school.
3. The school shall have to avail well furnished Building, Furniture, Laboratory, Library, Instruments, Stationary and other required things. Moreover, qualified educational staff must be appointed. The school shall have to get proper health facilities for students also.
 - 3-A. If there is "Uttar Buniyadi" then it shall have to create facilities for industries, Land, Water, Workshop Room for industry as per rules and regulations.
 - 3-B. The "Uttar Buniyadi" school shall have to create hostel facility.
4. The board must be satisfied that, the education given in the school is proper.
5. The school must use the text books sanctioned by the government.
6. The school can give the admission to the students as per rules and conditions of the board.
7. The students who have passed the examination then they should be promoted as per rules of the board.
8. The fees and the salaries of employees, such as educational or uneducational must be as per rules.
9. The school has to maintain registers and records as per rules of board.

10. The records and financial register and certificates which are introduced by Head Master or Executor of the school must be trustable.
11. The Board must be satisfied frequently that the staff and students adhere to the rules and regulations of the board.
12. The school has to give assurance that no other non-senctioned school or class runs in the school building and this assurance should be given by executors of the school to board.
13. The school shall never be ready for the students to appear in the examination higher than the examination except the examination which is held by Examination Board, Vadodara named "Primary School Certificate Examination" school shall not train the students to appear in the examination higher than above examination.
14. If the school gets grant from the government, then it shall not be allowed to refuse to give admission of any students of any religion, caste, language or any other reasons.
15. The school cannot start or close any new or old standard without prior permission of the board or district education officer.
16. More information of grant or recruitment of staff can be done as per the guidance of district education officer.
17. A convenient house accommodation of school and other physical facilities are done and should be informed within one month to board or district education officer.
18. Due to registration of your school, if the class is closed and if there is surplus teacher in any surrounding school then you shall have to recruit him.
19. The salary should be paid to the staff every month regularly from joint account as per government rules.
20. School shall have to obey conditions as per government rules under order

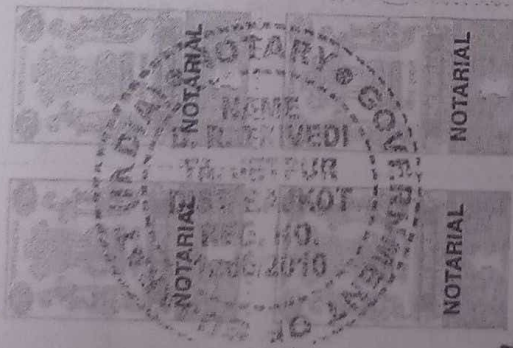

Inconnection with above have to inform you that, the class of Std.10th of **WITHOUT GRANT OF ENGLISH** Medium is to be started and it's consent is to be needed as per Gujarat Primary Education Rule, 1972(Gujarat Rule No.18 of 1973) and as per decided rule of 1974 and decision taken time to time by circulars and as per it the senction is given under following conditions :

1. There must be enough place as per the house and its area and there must be full light and air as per health conditions and facilities thereof.
2. Due to this standard there must be recruited qualified teachers for necessary subjects and appointed immediately of must be as per guidance of distance education availed.
3. As soon as the standard 10th is started the quilified Head Master must be appointed.

4. As per standard 10th study, the necessary items like laboratory, science instruments and other educational things and furniture should be furnished.

5. The required books for this study and other reading books for this standard have to be purchased and library for this is to be made.
6. It is to be careful that, there should not be competition with other surrounding such schools which is not desirable.
7. The amount as per Rule should be kept in joint account and the salary of teachers is to be paid from it.
8. According to Industrial rules there must be provided facilities of land, workshop, hostel etc. for "Uttar Buniyadi" school.
9. The students, studying in this school must be given priority at first for the admission in this standard.
10. The Rules which are prevailed at the time for grant shall be applicable and the same shall be of Government and Higher Education Commissioner.
11. If the school is not noted for grant then it should obey the rules and conditions as per Government Rules under circular dated 03-07-'93/BMS/1093/13222/Chh.
12. As per rules of education section Dt.28-08-'98 v/s Gujarat High Court special C.A.No.1066/98 this sanction is subject to its final judgement.

NOTES :

1. The educational fees Rs.200/- for registration of annual year 2002 with application shall have to be sent at examination section Vadodara and thereafter time to time fees will be sent.
2. The information of standard 10th is to be sent to the Board.
3. The involvement of above conditions, as well as standard is to be started and the report of the same is to be sent within 15 days to board and to educational officer.
