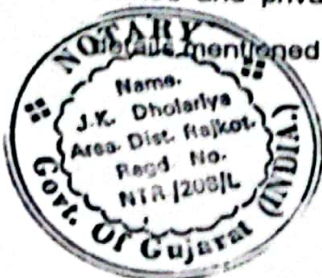

- B. This said trust will work for developing/advertising of education, and will do all activities & deeds for the purpose of helping to others institutes.

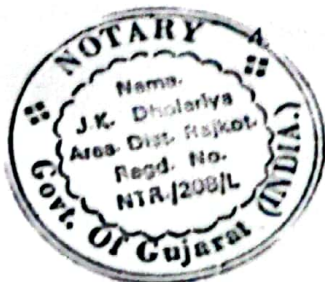
05. TRUSTEES :-

03. FIRST BOARD OF TRUSTEES. :-

Above-mentioned 9 trustees will remain/stand lifetime trustees of this trust. Out of lifetime trustees, one will be elected as a managing trustee. Presently, Shri Chandubhai Valjibhai Chhayani will remain as a managing trustee. And on vacated places, remaining trustees will appoint persons as a trustee with unanimously. In case of death, retirement, resignation of trustee, remaining trustees will appoint persons as trustee with unanimously.

04. The trustees meeting will be meet twice time in a year, managing trustee may call for meeting after issued notice in 5 days advance, for special meeting, he may call for meeting after issued notice in 1 day advance. The proceeding of meeting will proceed under presiding of managing trustee. In the absence of managing trustee, remaining trustees will appoint one trustee out of them as a managing trustee. Meeting quorum will be of 5 trustees.

05. One person, two persons or either of two decided by managing trustee and trustees board will do financial work/management. In addition to above mentioned deeds and activities of trust, the board of trustee may purchase/sale immovable property, mortgage and invest of money.

06. Trustees may not service by getting salary or remuneration from institutes managed by this trust. If they have sufficient qualification/knowledge of technical, educational and professional, they may service in any institutes managed by this trust, and get salary or



06. RESERVE :-

This trust will collect reserve as per below :-

1. Getting Income from trust property.
2. Getting donation, fund, gift and subscription.
3. Getting grant, subsidy and help/aid/assist from government and semi government, institutes and persons.
4. Getting Loan and deposit.
5. Taking over trusts having similar activities.

07. ACCOUNTS :-

The accounts of this trust will be kept/maintained as per Gujarati method.

08. YEAR :-

The accounting year of this trust will stand/remain as financial year. It means, it will start on 1st April upto 31 March.

09 DISSOLUTION :-

In case of arising of question to dissolve trust, under any circumstance. The trustees board will take immediately charge of trust and maintain proceed of trust. After completed responsibility of trust, trustees may dissolve of trust under trustees board resolution and hand over remaining trust property to any institutes/trusts engaged in similar activities/aims/objects,

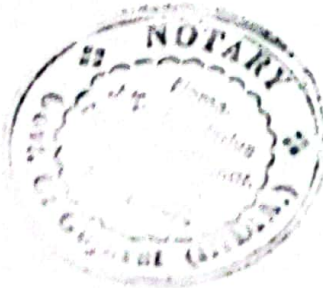
